

VAMOUSSE LICE ELIMINATION POWDER

Proven to kill lice and dust mites by contact in the household environment following a 1-hour exposure. Completes the elimination process by killing lice on non-washable household items following a lice infestation. Safe when used as directed.

READ ENTIRE LABEL BEFORE USE | DIRECTIONS FOR USE:

Canister contains enough powder to treat approximately 150 square feet. Apply to dry surfaces only. Do not wet powder. Do not apply on wet or damp carpet or upholstery.

FLOORING: Apply powder liberally over the entire surface by gently shaking from a distance of 6–8 inches. Wait at least 60 minutes to ensure all lice have been contacted by the product. **Thoroughly vacuum to completely remove product before resuming use of the area.**

FURNITURE: Test fabric in an inconspicuous area to evaluate any staining before using. Apply powder liberally over the entire surface by gently shaking from a distance of 6–8 inches. Pay particular attention to creases and corners, including areas between cushions. Wait at least 60 minutes to ensure all lice have been contacted by the product. **Thoroughly vacuum to completely remove product before resuming use of the area.**

STORAGE AND DISPOSAL: Store in closed container at room temperature in a cool, dry area away from children and pets. **CONTAINER HANDLING:** Nonrefillable container.

If empty: Do not reuse or refill this container. Place in trash or recycle if available.

If partly filled: Call your local solid waste agency for disposal instructions.

KEEP OUT OF REACH OF CHILDREN | PRECAUTIONARY STATEMENTS:

CAUTION: Causes moderate eye irritation. Avoid contact with eyes or clothing and inhalation of dust. We recommend that those with asthma or severe allergies consult their doctor before using this product and have someone else apply this product. Wash hands thoroughly with soap and water after handling. May cause an allergic skin reaction. Avoid contact with food, food processing surfaces and utensils. Remove children, pets, birds, and cover fish aquaria before applying. Vacate room after treatment and do not allow children or pets to contact treated areas until the product has been thoroughly removed. During prolonged exposure to dust, use of a NIOSH approved respirator is recommended.

NOT FOR USE ON HUMANS OR ANIMALS.

FIRST AID: Have the product container or label with you when calling a poison control center or doctor or going for treatment.

IF IN EYES: Flush repeatedly with water. Remove contact lenses, if present, after the first 5 minutes and continue rinsing eyes until they are no longer irritated. If discomfort persists, consult a physician.

IF ON SKIN: Wash thoroughly with soap and water.

IF INHALED: Get to fresh air. If breathing has stopped, call 911 or an ambulance; qualified personnel should administer artificial respiration, if possible.

IF SWALLOWED: Immediately call a poison control center or doctor for treatment advice. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
